

Publication Agreement

Dear Contributor,

Wipf & Stock Publishers (the “Publisher”) is pleased to undertake the publication of your essay,

The Contributor retains copyright to the Contribution and may use it in any publication authored by the Contributor without requesting permission from the Publisher.

WARRANTY: The Contributor warrants that the Contribution is original; that it contains no matter that is libelous or is otherwise unlawful or that invades individual privacy or infringes any proprietary right or any statutory copyright; and the Contributor agrees to indemnify and hold the Publisher harmless against any claim or judgment to the contrary. Further, the Contributor warrants that she/he has the right to assign the publication rights to the Publisher and that no right protected by copyright or publication right to the Contribution has been previously assigned. It is understood that the copyright to the Contribution has not been registered with the United States Copyright Office.
